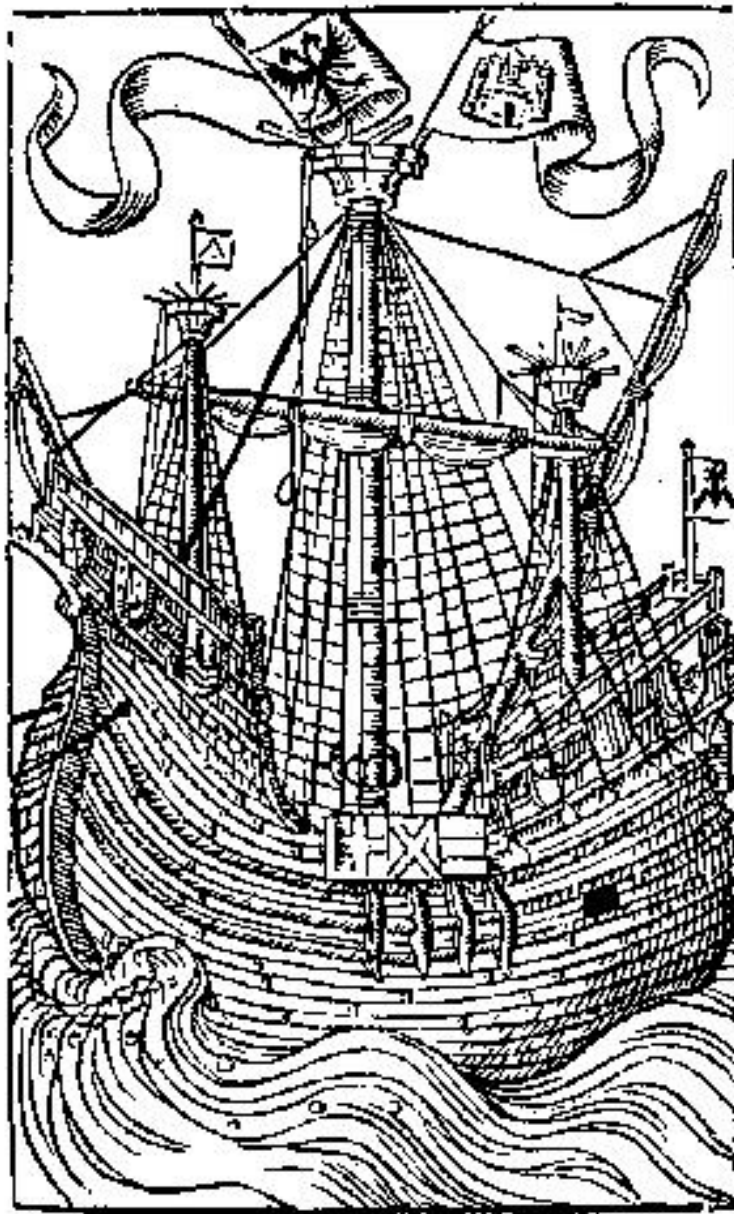

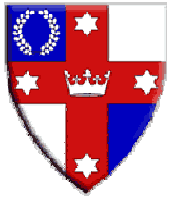

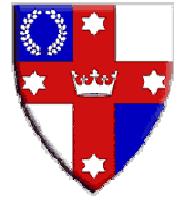

The Battle of Lepanto - the Cliff Notes Edition

- ❖ Took place on 7 October 1571
- ❖ Was between the Ottoman Empire (the Turks) and the Holy League which consisted of Spain, Venice, the Papal States, Genoa, Savoy and Malta
- ❖ Fought at the Gulf of Patras, off the western coast of Greece
- ❖ The Holy League had 208 ships compared to the Ottoman's 251 ships. This was the last naval battle fought mostly with oar-powered galleys.
- ❖ The Holy League forces were led by John of Austria, the illegitimate son of Charles V, the Holy Roman Emperor.
- ❖ Ali Pasha led the Ottomans and had been entrusted with the Banner of the Caliphs, which was very important to the Sultans. It was embroidered with the word Allah 28,900 times. Ali Pasha's ship was called the 'Sultana'.
- ❖ Ali Pasha was killed during the battle. His death and the capture of the banner severely damaged Turkish morale.
- ❖ The battle was won by the Holy League who destroyed the Ottoman fleet capturing 137 ships, sinking 50 ships, around 20,000 Ottomans died and 10,000 Christian galley slaves were freed. In comparison the Holy League lost only 17 ships and 7,500 were killed.

Southron Gaard Council Meeting

Tuesday 17th May 2011

OPENED: 7.36 pm

OFFICER REPORTS:

SENESCHAL (Oswyn): A short report. Correspondence with officers regarding their officer reports. Correspondence with officers regarding event reports. Correspondence with stewards regarding current and future events. Correspondence with the Kingdom Seneschal regarding quarterly reports. Correspondence with a potentially interested participant about the SCA in general. Correspondence with the CCC regarding outstanding rent for the dance/rapier hall. Correspondence with Lowrens regarding the Financial Committee. Correspondence with HMtQ regarding the offer of a subsidy for members of the populace who have suffered losses in the earthquake. Welcome to new officers: Sir Callum as Marshal, Mistress. Eleanora as Webwright

CHRONICLER (Elisabetta): FTT sent to subscribers on 1 May. Not put up on website until 4 May as for some reasons I could not get on to website to upload it. Not sure what happened but it worked on 4 May. Deadline for next issue 20 May. No applicants as yet for position. Correspondence: Master William de Cameron and both Baronial webwrights about upload issue, contributors re columns and articles.

CHATELAINE (Chunegund): Attended Award Cord Making workshop. Received query from a member of the Kingdom of the East about the SCA ownership of Antarctica. I gave her links to our gallery and history articles, plus the official

Scott Base website. All garb is back, and I have prices for packs of transfer paper and possible label layouts. We already have some thread. Once these are printed I'll organise a stitching session (probably a Stuff Night) to apply them and go through the garb and see what needs throwing out and what is needed. Mordenvale keeps a garb database in Microsoft Access, this is a good idea if I can figure out how Access works. I have had contact with HE Elenora about a baronial copy of the Known World Handbook, I should receive this at council and be able to hand over the receipt for reimbursement as discussed last council. KWH came to \$35.97 including postage.

WEBWRIGHT (Eleanora): This is my first report in the role of web minister and it will be short as I have only been in the post two weeks. I got together with Mistress Antonia on Thursday 5 May evening to go over site at her place and she sent me some files including the documentation for the site which has the passwords, log-ins etc, and PDFs of the Web Minister's Handbook, Policy about Children etc. Since then I have done some minor page updates e.g. regnum, events page and Canterbury Faire main page. I have redirected emails for myself and Sir Callum, our new Marshal, and made some updates to the Google calendar, removing some 'regular' meetings that were no longer being held etc. I have signed up to the Kingdom web ministers' list. Once I have downloaded the entire site to my PC I will run a link-checker over it and also do an orphans report. Over the next six months I expect to build up a good picture of how the site is put together so that I will be able to do some tidying up. It seems that there are a lot of old pages that have been superseded. Ms Antonia tells me that redirecting to the new versions is currently being handled by a .htaccess file but I would like to change the old pages to true redirects so that it is easier to tell from the editor end which files are 'real'. I have asked William de Cameron about server-side technologies that might be able to do this as I am familiar with doing vbscript redirects in an ASP

environment. Removing unused pages and files or archiving them into a single directory will make the site easier to work with in the future.

REEVE (Richard): Monthly figures attached, which includes March, since I was unable to submit a report last month. Activities: 1) Completed the Domsday report and submitted to kingdom. Resolved all prior discrepancies in quarterly report I had encountered when reconciling to Ginevra's last report. Major points to note: a. Overall loss for the year of \$6226.85, largely as a result of late CF2010 payment (and some income) totalling to \$11314.45, and \$1336.90 of expenses (SCANZ and kingdom levies and profit share) relating to 2010 events. Adjusted profit taking this into account would be more like \$6424.50, largely due to CF 2011 (\$5926.30 profit). Almost all other events profitable by a good margin. b. Non-event expenditure of \$3011.73 c. Non-event income of \$2173.46 d. Net assets at end of year \$11324.88. No liabilities. Some cheques still outstanding though (included in this figure). e. Will send "useful" version to FTT. Version submitted to kingdom isn't really suitable for general reading. 2) Discussions with Raffé re CF 2011 reconciliation. a. Income figure unable to be reconciled. Although details were provided of breakdowns for feast, souvenirs etc, the total provided in the report was based on what I had provided to Raffé as the total amount banked. Really this should have been from his records of total taken. The initial difference I was concerned with was about \$870 however later found this was due to Raffé adjusting this for values he hadn't thought I had included, but already had. Discussed with Vitale who advised "that Reeves and Stewards find the best balance between book-keeping rigour and reasonable demands on volunteers". Need to discuss with Council what they feel is reasonable to expect of stewards in this area. b. Largely reconciled expenses, however appear to be missing about \$1352 worth of receipts, relating to food (meal plan). Some Lady Agnes believed she may have handed to me in order to get cheques written for reimbursement. Pretty sure I don't have them, and I believe I left them with her to be handed to Raffé for inclusion with his report. \$552 for meal provided by Gavin I definitely have never seen. c. On the whole, not super happy with financial recording of income. Expense side pretty good (remember we had an earthquake, so some missing receipts could well be

expected). Would like to be very much more involved with CF 2012 management though, particularly discussing/training stewards on proper income information and ensuring that the gate has the same standard of record keeping as pre-event bookings. Do not expect this to be onerous, just better thought-out. 3) Haven't progressed at all with policy documenting 4) Will work on setting up direct credit facility with Westpac as this beats writing cheques hands down.

Correspondence: March – emails regarding signatory requirements to include a SCANZ rep. Confirmed that Lowrens would stay on as a signatory in that capacity. April – various emails to reconcile parts of the DDay report. Email re donation from Australia for SG event/needs Few emails regarding budget/policy information from officers – Geoffrey (Archery), Ed (Rapier), Chunegund and Oswyn. Thanks to those that have responded. All very good. Will contact other officers individually.

A&S (Amalie): In place of Stuff Nights since April I have organised A&S afternoons the following weekend. In April Bjorn hosted a session on treating horn and working with bone. In May I hosted an award cord making session. This format is working well and I think I will keep with it as long as the hall remains unavailable.

CONSTABLE (Agnes): Nothing to report.

CAPTAIN OF ARCHERS (Geoffrey): Had some archery practises. Not much else happened.

RAPIER AND LISTS (Emilio): This quarter no injuries, breakages or authorisations reported. Baronial Anniversary was the only tourney held but had a healthy 9 combatants take part. Nothing further to report.

QUARTERMASTER (Angus): Proclaimed self as having been a bit slack.

EVENT REPORTS:

BARONIAL ANNIVERSARY (Isabel Maria): full report handed into Reeve. Figures to appear in next month's report and FTT, but a profit made.

CF (Raffé and Emilio): Stewards not present. Debrief deferred.

YULE (Elisabetta): Venue still good. Kitchen team confirmed. Date set for 2nd of July.

GLEN'S GAMES EVENING (Glen): Bid submitted: aiming for August so as not to clash with Lindisfarne or KAOS winter weekend. Venue not confirmed. Likely to be: no alcohol, no stilettos, no candles. Expect a cost of a few dollars for the trophies Lowrens is making. To accept provisional bid moved by Joanna, seconded Richard.

OTHER BUSINESS:

LABELS - Buying of labels for hire garb as proposed in Chatelaine's report: unanimously agreed.

FINANCIAL RECORD KEEPING OF EVENTS: Policies vary between groups. Kingdom Exchequer apparently happy for each group to have its own rules/methods. Discussion moved to how we can improve record-keeping at gate for CF. E.g., having two people on at all times, one of them experienced? There being a

gate team for the event. They should have a calculator. Gate should be more visible. For Southron Gaard, there was consensus that stewards should provide all receipts collected: and a list of attendees showing both how much they were supposed to pay (non-member's fees, meals, particular activities, etc., as applicable) and how much they actually did pay. Richard to write up a policy and put it to the SG list for discussion.

EARTHQUAKE DONATION: BA - tickets could be paid for out of profit rather than by the Queen. \$300ish from Aneala - envisaged being used to subsidise an event (making it more flash, or subsidising the ticket price), or replace lost baronial goods, or replace SCA goods of SCAdians who have lost any in the quake. Council felt the funds could be used to help fund Yule, or to help SCAdians in need. Another message to go out to the populace asking anyone if they know of suitable candidates. Oswyn to doublecheck with fundraisers in Aneala just to make sure they are happy with either of these uses for the money.

MEETING CLOSED: 8.52.

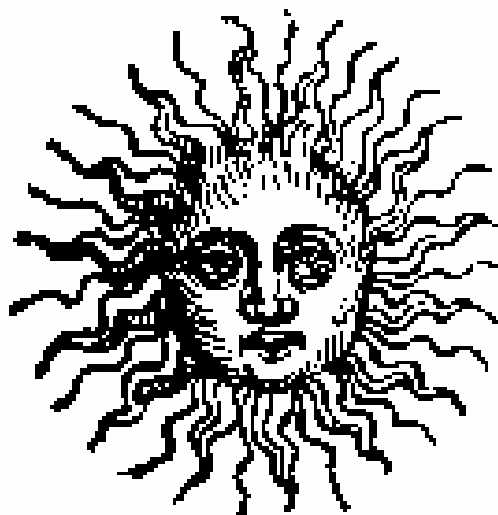

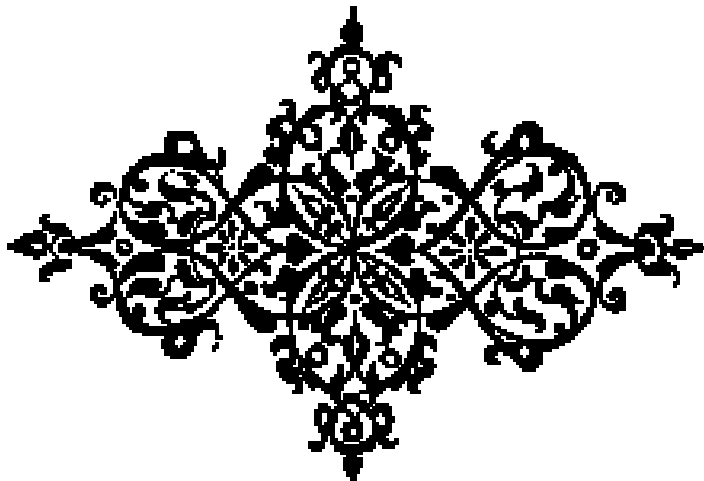
